The first share purchased is the share that confers Membership of the Society. This is your **Membership Share**. All shares are withdrawable subject to the Rules of the Society, but **you must retain your Membership Share to remain a Member of the Society**.

The Management Committee may refuse any application for membership at its absolute discretion.

Your data will not be used for any other purpose than that you have consented for and will not be passed on to any third parties. If you wish to change your consent please send a written request to the Society's Secretary.
